5. Introduction of Brittany Kleinman:

10. Snohomish County REET Grant Application:

- Real Estate Excise Tax Money can only go to certain types of uses. Has to fit into parameters the state has outlined.
- There was a meeting to determine what this grant could be used for that would qualify and benefit downtown. The idea came up about having a sound system throughout the city. It turns out a project like this would be way over the amount of this 10k grant
- The next idea is to purchase bike racks, benches & to enhance the merchant parking lot (next to Playa Bonita)
- Has to be something we can tie back to the cities comp plan (20 year outlook), every 5 years revised, every 10 years rewritten
- The next meeting is not yet scheduled, looking at early next week
